Completed artwork will be exhibited outside (under tents) at the Nanticoke River Jamboree event at Handsell Historic Site, 4837 Indiantown Rd, Vienna, MD 21869 on Saturday, October 12, from 10 a.m. – 5 p.m. Artists will display their works on their own easels, tables or other display panels and handle all sales. 10% of proceeds of sale suggested as a donation to support the NHPA, a 501(c)3 organization.
